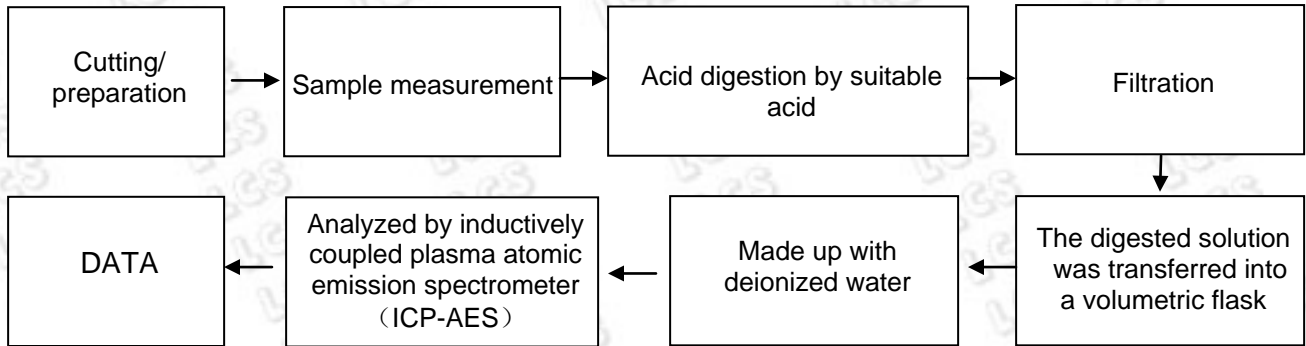

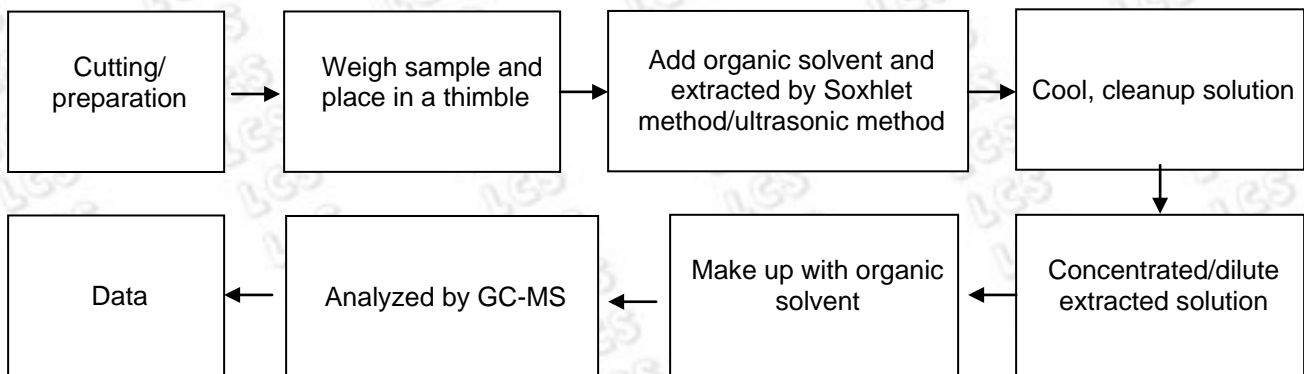

Test flow chart for Total Lead Content:

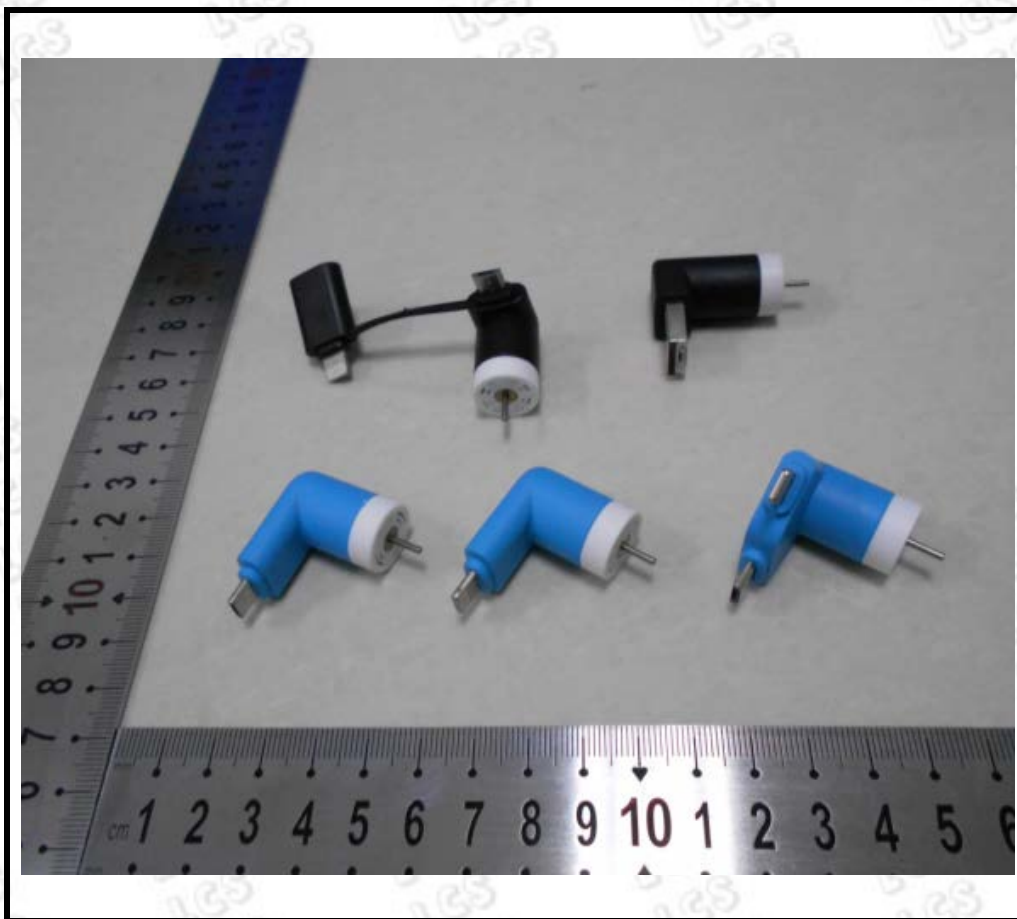


Test flow chart for Phthalates content:
